A proposed settlement has been reached in a class action lawsuit against Flex-N-Gate LLC, Flex-N-Gate Plastics, LLC, and Flex-N-Gate Chicago LLC (collectively, "Defendants") and individuals who provided a hand, palm, or finger scan to Defendants between November 7, 2014 and December 19, 2022 (the "Class Period") allegedly in violation of the Illinois Biometric Information Privacy Act ("BIPA") and the law. The case is *Seyon R. Haywood & Robert Stewart v. Flex-N-Gate LLC, et al.*, 2019-CH-12933, pending in the Circuit Court of Cook County, Illinois, County Department, Chancery Division. Defendants deny the allegations that have been made against them and deny that they have violated BIPA or the law. The proposed settlement is not an admission of wrongdoing by Defendants or that any of the scan information was compromised in any way. The Court has not decided who is right or wrong. Rather, to save the time, expense, and distraction of litigation, the parties have agreed to settle the lawsuit. The settlement has been preliminarily approved by a court in Chicago, Illinois.

Why am I being contacted? Our records indicate that you are a resident of the State of Illinois and provided your hand, palm, or finger scan to one or more of the Defendants between November 7, 2014 and December 19, 2022.

Who is Included in the Class? "All residents of the State of Illinois who had their hand-, palm-, or finger-prints collected, captured, received, otherwise obtained, or disclosed by the Defendants while residing in Illinois."

What Does the Settlement Provide? Defendants have agreed to create a fund totaling to pay settlement administration expenses, attorneys' fees and costs, Class Representative Incentive Awards to Plaintiffs Seyon R. Haywood and Robert Stewart, and pro rata shares of the remaining Settlement Fund payable to each Settlement Class Member which will be distributed by check in three approximately equal payments in 2023, 2024, and 2025. Your Rights May Be Affected. If you do not want to be legally bound by the Settlement, you must exclude yourself by July 31, 2023.
